Application Process

- 1. Please fill out the rental application and sign the last page. We can't run your credit unless we have your signature. We will need one application per adult.
- 2. Drop off the application at our office along with the \$25.00 fee for the credit and background check. This fee must be paid in cash or cashier check made out to Bordertown Realty. We do a credit and background check on every tenant and we are charged for this service. The fee is non-refundable and you will receive a copy of your credit report. If the information you gave us on the application is incorrect and we have to run the credit and background check again you would be charged the \$25.00 fee again. - 3. After receiving your application, we will process the application and review it with the owner to make a decision.
- 4. After the owner has accepted you as a renter Bordertown Realty will contact you to set up a move in date and a time to have you come in and sign a lease and put down the security deposit. The security deposit will need to be either cash or cashier check made out to the owner. We continue to show the rental until the lease has been signed and the security deposit has been paid.
- 5. On your move in date you will pay that month's rent with either cash or a personal check and pick up the keys for the rental property. Also, if there is a pet deposit that will have to be paid before you move in.
